8. Correspondence

The league has received several queries regarding Summer League, unfortunately due to the length of the season there will not be a MKINL Summer League this year.

An email was received from Fusion appealing a point deduction made regarding duty on 21st February. The committee agreed that the deduction stands. It is the responsibility of all

teams to check for changes to duty when changes are made to the fixtures, the committee will highlight changes in the future to assist with this.

An email was received with concerns regarding the umpiring at a match played on 4th April. ACTION - AC will look into this.

9. AGM

Due to the length of the season this year we are unable to confirm a definite date for the AGM until all matches to be replayed are arranged. We will notify all teams as soon as we can.

10. Any other business

The committee are reviewing the make-up of divisions to enable a shorter season next year to avoid issues with arranging a summer league and the AGM.

Chelbridge Rockets were late for duty on 22nd November 2016 causing others to have to set up duty. Chelbridge Rockets to be deducted 6 points as per MKINL Rule 5.3

TI explained that she arrived to umpire a match at 9.30pm on 25th April at Bletchley Leisure Centre to be informed that as an assessment was taking place she was not required to umpire. TI and RC, the umpires originally arranged to umpire this match, had not been informed that this was taking place.

ACTION – AC to contact TI and RC with an explanation.

A disciplinary hearing was held prior to the meeting regarding player conduct at a match that took place on 24th January 2017. The disciplinary panel assessed the evidence provided by the umpires, duty team and player in question and could not, on the balance of probability, approve a sanction.

ACTION: MKINL to formulate and agree a formal Disciplinary Procedure.
